Completion of the 2020 round of negotiations

On the 23rd of February, more than 160 delegates from the school sector, cegep support sector, consolidated ferry service sector, consolidated legal aid sector and the unions representing of the Olympic park participated in a virtual Public Sector (FEESP-CSN) meeting.

This meeting took place in order to close the last round of negotiations, as the delegates discussed and adopted the assessment of the 2020 round which was presented to them by the executive committee. This 2020 round, once again, proved the importance of union solidarity and and has resulted in significant gains, particularly for low-paid workers in the public and parapublic sectors.

Launch of the 2023 round of negotiations

One round of negotiations has barely ended and another has begun. As a matter of fact, seeing that the current collective agreements end on March 31st, 2023, the 2023 round was launched on February 24th, with an action, in front of the National Assembly, to unveil the slogan for this new round: **Du bon bord**.

The **bon bord** means: on the worker's side, public services side, the side of solidarity, school support staff's side, the cegep support staff's side, the side of legal aid support, on the side of the employees of the Olympic park, on the side of ALL the workers.

A sign that the members of the FEESP are already prepared for the new round: out of the 25,000 of the CSN public sector employees who submitted a survey to the central table, 7000 were members of the FEESP. This has never been seen and this huge participation calls for a next round to be highly colorful and very determined.
